### President's Column

We've had many positive comments about this summer's meetings in Halifax. Halifax was a great meetings site; our Canadian hosts put together a terrific program and gave us a warm welcome. Meeting jointly with the Canadian Society was excellent and I'm sure all NAREA members who attended join me in thanking our Canadian hosts. We are especially grateful to Gary Fisher, Jill Hobbs, John Cranfield and Stephen Clark who organized the meetings and selected papers sessions. We're hoping to meet again jointly with CAES, possibly in Quebec in 2007 or 2008. Stay tuned.

Lori Lynch and Maryland colleagues are at work on the **2005 meetings in Annapolis**. Lori, along with Erik Lichtenberg, has been chairing the **2005 NAREA Workshop** committee; invasive species is the topic for the workshop. Additional information on the Maryland annual meetings and workshop are presented in this newsletter as well as initial hotel information. You can also get all this information, updates on the program, and more at NAREA's website (<http://narea.org/>).

There have been a number of changes in NAREA this year. Lori Lynch and Wes Musser of the University of Maryland took over from Peter Parks as editors of the ARER. Peter did an excellent job as editor; he's really made a contribution to NAREA through his work on the ARER. We're delighted that Lori and Wes have taken over the reins of the journal. Our journal remains in capable hands and the transition was smooth. Send your manuscripts to Lori and Wes!

The NAREA Executive Committee had a productive meeting this fall, which resulted in a number of decisions that should strengthen the financial situation of our Journal, the ARER, and to try and boost membership. We've talked for several years about the ARER pages charges, which have lagged behind most

of our cohort journals. Peter Parks reviewed the costs of publishing the journal and after deliberation, the Board voted unanimously to raise page charges to \$75 per page, a charge that leaves our page charges competitive with, or lower than, our cohort journals. We also voted to raise library subscription rates. Libraries were previously charged the individual rate (\$25); library rates will now be \$125, again comparable or somewhat lower than other journals.

For the first time in many years, NAREA membership declined significantly. NAREA has been bucking the trend in declining membership that most associations across the country have seen for several years. But as you'll see in the Secretary/Treasurer's report, we dropped from 354 regular members in 2003 to 265 regular members in 2004. The Board voted to spend some of our funds to promote the journal and encourage memberships. We've ordered a number of additional copies of the journal to send to prospective members. Our membership committee of last year, with Kelly Giraud doing the lion's share of the work, created a brochure to include in mailings to prospective members. We hope to expand our membership base by contacting colleagues in economics departments around the northeast this coming year. In many cases, we appear to have *lost* members because some of us simply forgot to renew. Did you remember to renew your membership this year?

Another issue currently under consideration by the Board is expansion of ARER to three issues per year. While the Board felt favorably about publishing three issues per year, we are cautious at this point given our current submissions and acceptance rates. Our plan is to promote the ARER during the coming year to try and rebound from our loss of members during the past year and to encourage more submissions, from current members, prospective members and other colleagues across the country. Once we feel confident that submissions have increased to a level that will support an additional issue for the long term, we would enthusiastically move to publish the third issue.

With these changes in place, we look forward to a prosperous new year for NAREA. The decisions made on page charges and library memberships will, we think, bring NAREA to a more secure financial position and will allow us to take some more aggressive actions in the future. My thanks to our Executive Board, and to our members who volunteer on NAREA committees.

Total submissions have been 33 manuscripts. Two manuscripts (6%) were returned to the authors without review as inappropriate for our journal. Three manuscripts (9%) have been accepted for publication; two of these appear in the October 2004 issue. Six manuscripts (18%) were rejected after one review. Fifteen manuscripts (45%) were designated review and resubmit. The remaining seven manuscripts, 21%, are still in the first round of review.

We are on schedule with the 2004 workshop papers. Assuming authors respond to the revise and resubmit on a timely basis, we are on target to have these papers ready for the April 2005 issue. We want to thank all the reviewers and editorial board members who have helped to review the manuscripts. It is only through the generous use of your time that the publication process is made possible.

The new editors are looking forward to working with the members in continuing the excellent tradition of *ARER*. In addition to reviewing manuscripts, we invite and encourage members to submit their manuscripts to *ARER*. The numbers reported above indicate your support, but the journal can always use additional manuscripts. Submitting more quality manuscripts will continue enhancing our journal. We hope that you send us your work and encourage friends and colleagues from around the region, country, and world to also send us their work.

## Call for Nominations: NAREA Award for Outstanding Public Service Through Economics

NAREA calls for nominations for the *2006 Award for Outstanding Public Service Through Economics*. This

## Nominations for NAREA Master's Thesis Awards

NAREA calls for nominations for Outstanding Master's Thesis Awards. The NAREA Outstanding MS Thesis Award includes a \$250 cash prize, a certificate, and publication of an abstract (250 word maximum) in the *Agricultural and Resource Economics Review* at no charge to the award winner.

The NAREA Master's Thesis Award of Merit includes a \$50 cash prize, a certificate, and publication of an abstract (250 word maximum) in the *Agricultural and Resource Economics Review* at no charge to the award winner. Up to three awards of merit may be granted.

These nominations for considerations by the Awards committee will be evaluated according to the problem formulation, conceptual approach, quality of research, and quality of communication. Nominations must be received by **February 11, 2005**.

Eligible theses include all those that meet the following criteria:

- (1) Accepted by any institution of higher learning in the Northeast including those in the Maritime Provinces, Quebec, and Washington, D.C. during the period January 1, 2004 to December 31, 2004.
- (2) The thesis topic addresses any of the issues within the purview of NAREA.

A maximum of two theses per department will be considered by the committee. Only those theses nominated by the department chair, or graduate program director, will be considered by the committee. Any member of NAREA may petition the Committee to consider a thesis accepted by another institution in the Northeast, including those in the Maritime Provinces, Quebec, and Washington, D.C. Before the thesis is considered, the Committee will evaluate the petition.

- (2) Six copies of the thesis;
- (3) Six copies of the abstract (250 word maximum).

**2005 NAREA Annual Meetings in Annapolis, Maryland  
Selected-Paper and Symposium Submission Instructions**

*Deadline for Submission: February 15, 2005*

*The 2005 Northeast Agricultural and Resource Economics Association Annual Meeting will be held in Annapolis, Maryland June 12-15. All selected-paper sessions will be organized by NAREA selected-paper chairs to ensure topical and quality sessions.*

Proposals for Symposia have no restrictions on format or content, but should emphasize audience discussion. Symposium proposals should include: 1) a title; 2) description of the topic; 3) reason why the topic is timely and of interest to the membership; 4) suggested format and description of the presentation; and 5) names and affiliations of presenters.

Selected-papers will be selected based on an extended abstract of no more than two pages, double-spaced, in a 12 point font. Abstracts not meeting these criteria will not be considered. The Selected-Papers Committee will review abstracts in terms of problem statement, methods, results, and relevance to NAREA membership. Individuals whose abstracts are selected will be notified on or about April 1, 2004 and will be asked to write a paper for presentation at the meetings in Annapolis, Maryland. Final papers must be submitted to the Chair of the Selected-Papers Committee no later than June 1, 2005. Individuals who do not submit a completed paper by June 1, 2005 will not have abstracts of their selected-papers published in the *Agricultural and Resource Economics Review*.

For each selected-paper submission, include a separate page with the following information:

- 1) Title of the Paper;
- 2) Corresponding Author (Name, Address, Phone/FAX/email);
- 3) Name of Presenting Author - is the presenter a member of NAREA? (Yes or No);
- 4) 50-Word Abstract (for publication in the *Agricultural and Resource Economics Review*);
- 5) Paper's subject area (choose from the following list)
  - a. Consumer
  - b. Environment
  - c. Marketing
  - d. Rural/ Regional Development
  - e. Resources
  - f. Trade
  - g. Production
  - h. Other - Specify

Symposia and Selected-Papers can be submitted either by mail or electronically. Mailed proposals must be postmarked **no later than February 15, 2005**. Electronic submissions must also be sent by this date. If submitting electronically, please name the file as follows: NAREA *yourlastname.doc*. **Call for Papers**  
**2005 NAREA Workshop on:**

***INVASIVE SPECIES***  
***June 14-15, 2005***  
***Annapolis, Maryland***

The Invasive Species Workshop will be held in Annapolis, Maryland, on June 14-15, immediately following the annual meeting of the Northeastern Agricultural and Resource Economics Association (NAREA). We are seeking papers that will generate discussion among economists, other social scientists, ecologists, and biologists to further theoretical and empirical knowledge of the problems associated with invasive species prevention and mitigation policies and to identify key areas for further research. Three broad areas of research will be highlighted: (1) interactions between trade and invasive species policies; (2) incorporating ecology and biology into economic models for policy evaluation; and (3) examining the efficiency of policies and regulations for managing invasive species. The workshop will be open to papers examining such issues as: the impacts of invasive species on managed and natural ecosystem services, commercially cultivated commodities, and valuable or endangered indigenous species; relative efficiencies of alternative management, surveillance, and eradication policies; how trade agreements, increased trade, and travel have impacted the probability of invasive species introduction; the economic efficiency of exclusion programs in light of the increased risks of introduction; evaluations of tariffs and non-tariff barriers to international trade with respect to invasive species; the efficiencies of compensation programs for producer losses given eradication or mitigation policies; social welfare effects of invasive species; apportionment of responsibility for invasive species management across government entities, producers, consumers and property owners; impacts of land-use changes, cropping patterns, other management decisions, etc. on the risk of and damage caused by invasions; cost-effectiveness of surveillance and early warning systems; and others of interest.

Workshop proceedings will be published in a special issue of the Agricultural and Resource Economics Review (ARER) if accepted after the journal's normal review process. An honorarium of \$1,000 will be provided for selected papers upon submission of the paper to ARER by July 15, 2005.

To submit a paper for consideration by the Workshop's selected paper committee, please e-mail a five-page abstract (MS Word or PDF attachment) with a title but no other identifiable information to Dr. Cheryl Brown at the e-mail address below. The five-page limit relates to text only and excludes tables, figures, and literature cited. The deadline for abstracts is Friday, February 4, 2005. Authors will be notified of the status of their abstract submissions by March 31, 2005. Full papers must be received from notified authors by May 1, 2005 to be considered for inclusion in the program. ARER must receive papers by July 15, 2005 to be considered for expedited review. Further information concerning the workshop will be provided in upcoming issues of the NAREA Newsletter and the AAEA Exchange. Cosponsors include: U.S. Environmental Protection Agency, USDA Economic Research Service, and Farm Foundation.
